This Schedule 13D is filed on behalf of Carl H. Lindner III (the "Reporting Person") with respect to the relative to the no par value Common Stock (the "Common Stock") of American Financial Group, Inc. ("AFG").

Item 4. Purpose of Transaction.

The Reporting Person is the Co-Chief Executive Officer and Co-President of AFG and also serves on the Board of Directors. In these capacities, Mr. Lindner has responsibility for AFG's management and strategic direction. Additionally, in his capacity as a shareholder of the Company, Mr. Lindner reviews his investment in the Company on a continuous basis. Mr. Lindner may from time to time acquire additional shares of Common Stock of the Company or dispose of a portion of the shares of Common Stock that he beneficially owns. Any transactions that Mr. Lindner may pursue may be made at any time and from time to time without prior notice and will depend upon a variety of factors, including, without limitation, other investment and business opportunities available to Mr. Lindner, tax and estate planning considerations and other factors.

Other than as described above in this Item 4, Mr. Lindner has no present plan or proposal relating to or that would result in any of the transactions or changes listed in Items 4(a) through 4(j) of Schedule 13D.

As of March 28, 2020, the Reporting Person beneficially owned 5,450,844 shares (or approximately 6.1% of the outstanding shares) of Common Stock, which amount includes 2,623,593 shares held in a trust over which he holds voting and dispositive power; 343,162 shares held by a trust over which his spouse has voting and dispositive power; 838,480 shares held in a limited liability company over which he holds dispositive power; 355,585 shares held by a charitable foundation over which he shares voting and dispositive power; 3,984 shares held in trusts for family members over which he holds voting and dispositive power; 136,040 shares held in two charitable foundations over which he and/or his spouse have or share voting and dispositive power; 1,000,000 shares held in a trust over which he holds voting power; and 150,000 shares issuable upon exercise of employee stock options within 60 days of the date of filing.
